Pental Fund Services Limited is the responsible entity for the Pental Sustainable Australian Fixed Interest Fund (Scheme). As responsible entity, it is responsible for overseeing the operations of the Scheme.

Pental Institutional Limited (ABN 17 126 390 627) is the investment manager of the Scheme. As the investment manager, it selects and manages the assets of the Scheme and may appoint other managers to manage some or all of the Scheme's assets.

2. How the Pental Sustainable Australian Fixed Interest Fund works

How the Scheme operates

The Pental Sustainable Australian Fixed Interest Fund is a registered managed investment scheme.

When you invest your money in the Fund, your money is pooled together with other investors' money. We use this pool to buy investments and manage them on behalf of all investors in the Scheme. This means that by investing in the Fund you have access to certain investments that you may not otherwise be able to access on your own as well as the knowledge of our skilled investment managers. However, Pental has day-to-day control over the operation of the Scheme.

The Scheme offers multiple classes of units to investors. From time to time, Pental may issue additional classes of units in the Scheme, each with different rights and entitlements. Investments made under this PDS are for units in Class R of the Scheme, and the rights and entitlements disclosed in this PDS are specific to the Class R Units. The total value of the assets held in the Scheme are divided into units based on the classes in the Scheme. A reference to a 'unit' in this PDS, is a reference to the Class R units of the Scheme. Each unit carries an equal beneficial interest in the Scheme as a whole but does not give an investor an interest in any particular assets of the Scheme. The unit price for Class R is generally calculated for each Business Day based on Class R Units' share of the Scheme's net asset value. The unit price will generally change daily as the market value of assets in the Scheme rises or falls.

When you make an investment in the Fund, we will allocate units to you based on the entry price for the Business Day on which we accept your application and we will keep a record of the number of units you have bought. When you withdraw, we will redeem your units based on the exit price for the Business Day on which we receive your withdrawal request.

Entry prices are usually higher than exit prices due to the 'buy-sell spread'. The buy-sell spread is built into the unit price and represents your contribution to the costs of buying and selling the underlying assets in the Scheme.

Entry and exit prices for each Business Day will be available at www.pentalgroup.com by clicking on 'Products', select the Scheme, and click on 'View fund information'. Prices will usually be posted by the end of the next Business Day.

We have also adopted a unit pricing discretion policy setting out the principles that apply when we exercise discretions under the Scheme's constitution. You can request a copy of the policy free of charge by calling us or by downloading a copy at www.pentalgroup.com/UnitPriceDiscretionPolicy.

Minimum initial investment

The minimum initial investment amount is \$25,000. In certain circumstances, we may reject an application or accept only

How to withdraw

You can withdraw some or all of your investment by completing the withdrawal form and sending this form to us via mail, email or fax. Investors also have the ability to transact online. For more information, please refer to www.pentalgroup.com/forms.

Withdrawals will generally be paid to your nominated Bank Account within 5 Business Days.

Restrictions on withdrawals

There may be circumstances where your ability to withdraw from the Fund is restricted and you may have to wait a period of time before you can redeem your investment.

We may suspend withdrawal requests at any time and for such period as we consider appropriate in certain circumstances including where it is impractical for us to determine the value of assets of the Scheme due to circumstances outside our control (such as restricted or suspended trading in the market for an asset) or where we reasonably consider that it is in the interests of investors or where the Scheme becomes illiquid.

If the Scheme is illiquid (as defined in the Corporations Act) withdrawals from the Fund will only be possible if we make a withdrawal offer in accordance with the Corporations Act. Under the Corporations Act, a scheme is illiquid if it has less than 80% liquid assets (generally cash and marketable securities).

Processing

If we receive an application or withdrawal request by 2.00pm (Sydney time) on a Business Day, we will process the transaction using that day's Class R unit price. Requests received on or after the cut-off time of 2.00pm (Sydney time) on a Business Day, or on a non Business Day, will generally be treated as having been received before the cut-off time on the next Business Day.

If we receive an invalid or incomplete application or withdrawal request, the transaction request will be processed using the Class R unit price applying on the day that we receive the correct documentation. The above rules about cut-off times apply.

Distributions

The Fund generally distributes on a quarterly basis with a final distribution each year for the period ending 30 June. In some circumstances, we may also pay distributions at other times during the year where we consider it appropriate.

Distributions that you receive are generally assessable income. The distribution amount will depend on the Scheme's distributable income.

The Scheme's distributable income is generally calculated based on the Scheme's net income at the end of the distribution period. The amount of your distribution will be proportionate to the number of units held by you relative to the number of units on issue. In certain circumstances, some income may be held back until the final distribution at the end of June to allow for market volatility. The Scheme may also distribute a payment out of the capital invested.

The Scheme's distributable income will vary and sometimes there might not be any distribution. Losses arising from the

realisation of a derivative position may adversely impact the Scheme's distributable income.

You can choose to have your distributions automatically reinvested into additional Class R Units in the Scheme or paid directly into your nominated Bank Account. There is no buy-sell spread on distributions that are reinvested. Reinvestment of distributions will normally be effective the first day following the end of the distribution period. Distribution payments to your nominated Bank Account are generally made within 12 Business Days after the end of the distribution period.

Indirect investors

We authorise the use of this PDS as disclosure to persons who wish to access the Fund indirectly through an Investor Directed Portfolio Service (IDPS), IDPS-like scheme or a nominee or custody service (collectively referred to as master trusts or wrap accounts).

Persons who invest in the Fund through a master trust or wrap account may be subject to different conditions from those referred to in this PDS particularly with regard to cut-off times for transacting, timing of distributions, processing and withdrawals as well as Fund reporting and investor notices.

3. Benefits of investing in the Pendal Sustainable Australian Fixed Interest Fund

Significant features

The Pendal Sustainable Australian Fixed Interest Fund is an actively managed portfolio of fixed interest securities. Investments are selected based on a range of financial, sustainable and ethical criteria.

Significant benefits

Investing in the Fund offers investors a range of benefits:

- access to a professionally managed portfolio of fixed interest securities;
- exposure to issuers that have passed Pendal's sustainability assessment while avoiding exposure to issuers with business activities that Pendal considers to negatively impact the environment and/or society¹;
- exposure to green, social and sustainable bonds that in addition to meeting the Fund's financial return objective, also aim to generate positive and measurable social and/or environmental outcomes; and
- access to Pendal's investment expertise and sustainability reporting.

4. Risks of managed investment schemes

All investments carry risk. The likely investment return and the risk of losing money is different for each managed investment scheme as different strategies carry different levels of risk depending on the underlying mix of assets that make up each fund. Those assets with potentially the highest long term return (such as shares) may also have the highest risk of losing money in the shorter term.

The significant risks for the Fund are:

- **Class risk:** The Fund has been established as a separate class of units in the Scheme. As the assets are held on trust for all investors, there is a risk that investors of one class, may be exposed to liabilities of another class of units and they could lose some or all of their investment in the Fund. There is also a risk that in the event of an insolvency, the assets of the Fund could be made available to creditors of another class of units of the Scheme.
- **Credit risk:** The risk of an issuing entity defaulting on its obligation to pay interest and principal when due. It arises primarily from investments in fixed interest securities and from certain derivatives.
- **ESG risk:** The sustainability criteria and exclusionary screens applied to the Fund's investments may exclude some industry sectors and issuers from the investable pool of the Fund's portfolio. For this reason the Fund's performance may vary when compared to other funds that are able to invest in these companies. This risk should be considered when deciding whether to invest in the Fund.
- **Interest rate risk:** The risk that the investment value or future returns of an asset may be adversely impacted by changes in interest rates. Interest rates may directly or indirectly affect a company's cost of borrowings as well as the value of fixed interest securities.
- **Legal and regulatory risk:** The risk that a change in laws and regulations governing a security, sector or financial markets could have an adverse impact on an investment. A change in laws or regulations can increase the costs of operating a business and/or change the competitive landscape. For example, a country may nationalise a business or industry which may result in investors losing some or all of their investment.
- **Liquidity risk:** The risk that an investment may not be easily converted into cash with little or no loss of capital and minimum delay. Fixed interest securities may have limited or no liquidity where there has been a default by the issuer, or deterioration in the creditworthiness or credit rating of a particular issuer or market. Liquidity risk may also extend to swap transactions, structured securities or derivative contracts which provide exposure to some types of assets or markets. This means that it may not be possible to sell these investments or to do so within a particular timeframe to pay withdrawals. If this occurs, there can be delays in the payment of withdrawals.
- **Manager risk:** The risk that the investment professionals employed to manage the Fund's investments will not perform to expectation or that changes to key investment personnel may have a material impact on the Fund's investment performance.
- **Market risk:** The risk that the market price of an asset will fluctuate as a result of factors such as economic conditions, government regulations, market sentiment, local and international political events and environmental and technological issues. Market risk may have different impacts on each type of asset, investment style and investor.

- Operational and cyber security risk: The Fund's operations may be adversely impacted by breakdowns in internal/external administrative processes or circumstances beyond our reasonable control, such as failure of technology or infrastructure, or natural disasters. Despite security measures, fraud, data loss/damage or business disruption may result from cyber threats against or unauthorised infiltration of our technology systems and networks or those of our service providers.
- Security risk: The risk that a particular asset that the Fund invests in may fall in value. The value of fixed interest securities can also be affected by specific events such as changes in the perceived or actual creditworthiness of a particular issuer. The risks to which the issuer is exposed can result in a reduction in the value of your investment.

Risk can be managed but it cannot be completely eliminated. It is important to understand that:

- the value of your investment will go up and down;
- investment returns will vary and future returns may be different from past returns;
- returns are not guaranteed and there is always the chance that you may lose money on any investment you make; and
- laws affecting your investment in a managed investment scheme may change over time.

The appropriate level of risk for you will depend on your age, investment time frame, where other parts of your wealth are invested and how comfortable you are with the possibility of losing some of your money in some years.

5. How we invest your money

Description of Fund	The Fund is designed for investors who want income and diversification across a broad range of fixed interest securities and are prepared to accept some variability of returns. The Fund invests primarily in Australian dollar denominated investment grade fixed interest securities, including government securities, semi-government securities, supranational securities and credit securities and holds cash. The Fund will invest primarily in investment grade securities but may also invest in non-investment grade securities. The Fund's maximum investment exposure to non-investment grade securities is limited to 10% of the value of the Fund. The Fund may also invest in securities that are not rated by external credit rating agencies. The Fund's maximum investment exposure to unrated securities is limited to 10% of the value of the Fund. The Fund also has the ability to invest in non-Australian dollar denominated securities³ to enhance returns when we believe market conditions are supportive. For non-Australian dollar denominated securities, the Fund will generally hedge back any foreign currency exposures to Australian dollars to the extent considered reasonably practicable. The Fund uses derivatives to gain exposure to assets and markets. Derivatives may also be used to reduce risk and can act as a hedge against adverse movements in a particular market or in the underlying assets. Pendal's investment process for fixed interest aims to add value through multiple strategies and investment research. Pendal seeks to generate excess returns through a combination of alpha strategies such as credit management, active security (including green, social and sustainable bonds) and sector selection, duration and yield curve. Our investment approach for credit management seeks to identify opportunities on a sector, issuer and security basis by incorporating top-down and bottom-up research. Top-down research includes analysis of economic and market data, along with macro credit fundamentals such as company earnings, balance sheet health, default rates and equity volatility. Bottom-up research includes analysis of earnings and cashflow volatility, balance sheet, business diversity, industry and valuation.	

² The reference to the Fund investing in an asset class includes all types of investments which give exposure to that asset, directly or indirectly, including through derivatives and investment in other funds which invest primarily in that asset class. Sustainability Objective	The Fund aims to allocate capital to issuers and securities that are aligned to the Fund's sustainability themes: climate stability, human basics and innovation for good (the Sustainability Objective). The Fund's sustainability themes include but are not limited to: • Climate stability: Actions towards a net-zero future, preserving climate stability, and biodiversity. • Human basics: Essential goods and services, key infrastructure, and access to finance, telecommunications, and insurance. • Innovation for good: Development projects for underserved communities, activities aimed at empowerment or resilience, and other actions that lead to human flourishing. The Fund aims to meet its Sustainability Objective by allocating capital to issuers and securities that are aligned to our sustainability themes by: • investing in securities issued by issuers that have passed our sustainability assessment; • avoiding exposure to issuers with business activities that we consider to negatively impact the environment and/or society⁴; • investing in green, social and sustainable bonds that in addition to meeting the Fund's financial return objective, also aim to generate positive and measurable social and/or environmental outcomes; and • maintaining an overweight allocation in aggregate to green, social and sustainable bonds that exceeds their combined weight in the Bloomberg Ausbond Composite O+Yr Index. The Fund's Sustainability Objective does not apply to derivatives. We undertake a sustainability assessment on all issuers that considers the extent to which each issuer manages its environmental, social (including labour standards) and governance (collectively ESG) risks (all of which include ethical factors). Our assessment draws on internal and external research to assess an issuer's sustainability performance (for example their exposure to ESG risks and how well they manage these risks relative to peers) and seeks to identify issuers that, in our view, have strong sustainability credentials for investment. Pendal also actively engages with the issuers that we invest in where we believe it is material in terms of managing risk, effecting change and realising potential value over the long term. Pendal's sustainability assessment process is explained further (under the heading, 'Sustainability Assessment') in section 4 of the 'Additional Information to the Product Disclosure Statement' at www.pendalgroup.com/PendalSustainableAustralianFixedInterestFundR-PDS.
Exclusionary Screens	In addition to our sustainability assessment, Pendal applies issuer-level exclusionary screens to the Fund's credit securities. The Fund's exclusionary screens aim to avoid exposure to issuers with business activities that Pendal considers to negatively impact the environment and/or society.⁴ The Fund will not invest in issuers directly involved in the following business activities: • tobacco production (including e-cigarettes and inhalers); or • controversial weapons manufacture (including biological weapons, blinding laser weapons, chemical weapons, cluster munitions, depleted uranium weapons, incendiary weapons, landmines, non-detectable fragments, nuclear weapons and white phosphorus weapons); or • supply of goods or services specifically related to controversial weapons. Additional exclusionary screens are also applied across different industries and business activities. Exclusionary screens are not applied to government securities, semi-government securities, supranational securities, derivatives or cash. This is because such securities, issuers or financial instruments are not able to be reasonably screened for involvement in activities that Pendal considers to negatively impact the environment and/or society.⁴ The use of derivatives may result in the Fund having indirect exposure to issuers that would otherwise be excluded. 6. Fees and costs

DID YOU KNOW?

Small differences in both investment performance and fees and costs can have a substantial impact on your long-term returns. For example, total annual fees and costs of 2% of your account balance rather than 1% could reduce your final return by up to 20% over a 30-year period (for example, reduce it from \$100,000 to \$80,000). You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs. You may be able to negotiate to pay lower fees. Ask the Fund or your financial adviser.

Additional explanation of fees and costs

Buy-sell spread

The buy-sell spread is an additional cost to you and is generally incurred whenever you transact in the Fund. The buy-sell spread is retained by the Fund (it is not a fee paid to us) and represents a contribution to the transaction costs incurred by the Fund such as brokerage, stamp duty and other costs of execution, when the Fund is purchasing and selling assets. There is no buy-sell spread on distributions that are reinvested.

The current total buy-sell spread is 0.14% of the amount that you transact, represented as the difference between the entry and exit price. A buy spread of 0.07% is applied on each application and a sell spread of 0.07% is applied on each

withdrawal. For example, if you invested \$50,000 in the Fund the cost of your buy spread would be \$35, and the cost of your sell spread on withdrawing \$50,000 from the Fund would be \$35.

7. How managed investment schemes are taxed

Investing in a managed investment scheme is likely to have tax consequences. Managed investment schemes generally do not pay tax on behalf of investors. However, we (or your master trust or wrap account provider) may be required to withhold tax from each distribution at the relevant withholding tax rates under certain circumstances.

As an investor, you will generally be subject to tax on your share of any taxable income generated by the Scheme and attributed to you. The Scheme has elected into the Attribution Managed Investment Trust (**AMIT**) regime. As an AMIT, the income attributed to you may be more than or less than the distributions you receive in respect of the financial year ending 30 June.

2. Direct investors should complete the Application and relevant Form(s). Please visit www.pendalgroup.com, click on 'Products', select the Scheme and click on the 'Apply' button. A copy of the forms can also be requested by calling us. Payment details and methods are included in the Application Form.
3. If you are a non-advised investor (an investor without a financial adviser) investing directly in the Fund, you may also be required to complete a series of questions as part of your online Application, to assist us in understanding whether you are likely to be within the target market for the Fund as described in the target market determination (**TMD**).
4. If you are a retail investor (as defined in the Corporations Act) investing directly in the Fund, you have a 14 day cooling-off period to confirm that the investment meets your needs. If you exercise your cooling-off rights, we will return your money to you and no fees will apply. However, the amount you receive will reflect any movement (either up or down) in the unit price of the Fund which means that

there may be tax implications for you. The 14 day cooling-off period commences on the earlier of the end of the fifth Business Day after we issue the units to you or from the date you receive confirmation of your transaction.
